EMERGENCY OVERVIEW

Warning! Causes eye, skin, and respiratory tract irritation. Target Organs: Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. May be harmful if absorbed through the skin.
